04 Health procedures

04.2 Administration of medicine

Key persons are responsible for administering medication to their key children; ensuring consent forms are completed, medicines stored correctly, and records kept.

Administering medicines during the child's session will only be done if necessary.

If a child has not been given a prescription medicine before, especially a baby/child under two, it is advised that parents keep them at home for 48 hours to ensure no adverse effect, and to give it time to take effect. The setting managers must check the insurance policy document to be clear about what conditions must be reported to the insurance provider.

Consent for administering medication

- Only a person with parental responsibility (PR), or a foster carer may give consent. A childminder, grandparent, parent/carer's partner who does not have PR, cannot give consent.
- When bringing in medicine, the parent informs their key person/back up key person, or room senior if the
 key person is not available. The setting manager should also be informed. Any controlled medicines will
 immediately be stored in the Managers locked office within a locked cabinet labelled with a green and
 white medicine sticker.
- Staff who receive the medication, check it is in date and prescribed specifically for the current condition.
 It must be in the original container (not decanted into a separate bottle). It must be labelled with the child's name and original pharmacist's label if prescribed.
- Medication dispensed by a hospital pharmacy will not have the child's details on the label but should have
 a dispensing label. Staff must check with parents/carers and record the circumstance of the events and
 hospital instructions as relayed to them by the parents/carers.
- Members of staff who receive the medication ask the parent/carer to sign a consent form stating the following information. No medication is given without these details:
 - full name of child and date of birth
 - name of medication and strength
 - who prescribed it (if applicable)
 - dosage to be given

- how the medication should be stored and expiry date
- a note of any side effects that may be expected
- signature and printed name of parent/carer and date

Storage of medicines

All medicines are stored safely. Refrigerated medication is stored separately or clearly labelled in the milk kitchen fridge, or in a marked box in the main kitchen fridge.

Any controlled medicines will immediately be stored in the Managers locked office within a locked cabinet labelled with a green and white medicine sticker. Staff are informed via the Nursery in a box portal that only management have access to the medicine. This is reinforced in staff meetings and staff inductions.

Medicines to save life such as hypo treatments are stored in the kitchen on top of the medicine cabinet, inside a plastic container clearly labelled with the child's name and photo. Inside will include medicines/treatments and a care plan. Staff are informed via specialist training how to store medicines and who can access. This is reinforced in staff meetings and staff inductions.

Medicines for staff, such as paracetamols will be stored in the kitchen in a high cupboard labelled with a green and white cross sticker for medicine. Staff are made aware that they can access the staff medicines when needed, using the labels for advice of usage. This is only to use for personal use whilst at work. Staff are informed in staff meetings and inductions.

- The key person is responsible for ensuring medicine is handed back at the end of the day to the parent/carer.
- For some conditions, medication for an individual child may be kept at the setting. 04.2a Healthcare plan form must be completed. Key persons check that it is in date and return any out-of-date medication to the parent/carer.
- Parents/carers do not access where medication is stored, to reduce the possibility of a mix-up with medication for another child, or staff not knowing there has been a change.

Record of administering medicines

A record of medicines administered is kept near to the medicine cabinet or in the child's group room, or in the setting manager's office. Settings can choose which works best for them if members of staff are aware and it is consistent.

Controlled medication has a two step record of administration. One form is to be completed on the box of the medicine, alerting if medication has been given that day. Second form is completed on Nursery in a box, this records the times, dosage, who administrated and who witnessed. This alerts parents for their signature.

Controlled medicines are to be given by the keyperson and a manager. Staff are informed via Nursery in a box, staff meetings and staff inductions. Keypersons will be taught by management how to complete a form when medication is handed over. Management will supervise the completion until the keyperson is confident.

The medicine record, records:

- name of child
- name and strength of medication
- the date and time of dose
- dose given and method
- signed by key person/setting manager
- verified by parent/carer signature at the end of the day

A witness signs the medicine record book to verify that they have witnessed medication being given correctly according to the procedures here.

Controlled medication will be witnessed by a manager, alongside the keyperson or another manager in their absence.

- No child may self-administer. If children are capable of understanding when they need medication, e.g.
 for asthma, they are encouraged to tell their key person what they need. This does not replace staff
 vigilance in knowing and responding.
- The medication records are monitored to look at the frequency of medication being given. For example,
 a high incidence of antibiotics being prescribed for several children at similar times may indicate a need
 for better infection control.

Children with long term medical conditions requiring ongoing medication

- Risk assessment is carried out for children that require ongoing medication. This is the responsibility of the setting manager and key person. Other medical or social care personnel may be involved in the risk assessment.
- Parents/carers contribute to risk assessment. They are shown around the setting, understand routines
 and activities, and discuss any risk factor for their child.
- For some medical conditions, key staff will require basic training to understand it and know how medication is administered. Training needs are part of the risk assessment.
- Risk assessment includes any activity that may give cause for concern regarding an individual child's health needs.
- Risk assessment also includes arrangements for medicines on outings; advice from the child's GP's is sought, if necessary, where there are concerns.

Policies & Procedures for the EYFS 2025/26 (Early Years Alliance 2025)

- 04.2a Health care plan form is completed fully with the parent/carer; outlining the key person's role and what information is shared with other staff who care for the child.
- The plan is reviewed every six months (more if needed). This includes reviewing the medication, for example, changes to the medication or the dosage, any side effects noted etc.

Managing medicines on trips and outings

- Children are accompanied by their key person, or other staff member who is fully informed about their needs and medication.
- Medication is taken in a plastic box labelled with the child's name, name of medication, copy of the consent form and a card or electronic device to record administration, with details as above.
- The card is later stapled to the medicine record book and the parent signs it.
- If a child on medication must be taken to hospital, the child's medication is taken in a sealed plastic box clearly labelled as above.

Staff taking medication

Staff taking medication must inform their manager. The medication must be stored securely in a secure area away from the children. The manager must be made aware of any contra-indications for the medicine so that they can risk assess and take appropriate action as required.
